MINUTES FOR MARCH 30, 2020

The March 30, 2020 Council teleconference meeting was called to order by President Speicher at 4:00 p.m.

Solicitor Carbonara reviewed the disaster declaration he had created in response to the novel coronavirus being declared a public health emergency and a state of emergency being declared by the Cambria County Commissioners. Council discussed holding the April 20, 2020 monthly council meeting via teleconference. Solicitor Carbonara stated a quorum would still needed, public participation needs to be included somehow, the meeting needs to be recorded and made available to the public, and the meeting and teleconference information should be advertised and posted on the borough website and municipal building door. A motion was made by Mr. Rodgers to approve holding the April 20, 2020 monthly council meeting via teleconference and advertising such in the Tribune Democrat. Motion seconded by Mr. Pile. Mr. Paolini and Mr. Ewald absent. Roll call: Mr. Danyluk, Mr. Rodgers, Mr. Pile, Mr. Morgan and Mrs. Speicher in favor. Mr. Paolini and Mr. Ewald absent. Motion carried (5-0).

There being no further business, a motion was made by Mr. Rodgers for adjournment of the March 30, 2020 meeting at 4:24 p.m. Motion seconded by Mr. Danyluk. Mr. Paolini and Mr. Ewald absent.
