Chief Lose reported the West Hills Regional Police 4th Annual Open House on July 27th from 11am-2pm.

Fire Company's Report

Chief Butler stated a report for May 2019 was not available yet noting the member that created the reports stepped down from the fire company and they are trying to find someone to take over for him.

Chief Butler stated the Jubilee was a success noting they were only down approximately \$7,000 from the previous year despite the bad weather and tornado watches throughout the week.

Solicitor Carbonara reported the easements for the triangle on Menoher Blvd. have been filed and Snyder Environmental Services has been notified that they can begin the laterals in that area.
