#### Meeting Agenda

#### **Visitors**

Mr. Walker is very concerned about the deer population in the borough. He and neighbors are having property damage from the vast numbers coming into the borough. After discussion, Mr. Morgan said there is a program that Westmont, Upper Yoder and Johnstown are looking into the issue with the PA Game Commission.

A motion was made by Mr. Ewald for Mr. Morgan to explore the program for Southmont Borough to participate. Motion seconded by Mrs. Speicher. Mr. Pile absent. All in favor, motion carried (6-0).

# Police Chief's Report

The September 2019 West Hills Regional Police Department report was received and is on file. The speed monitoring board is not working at this time and the police are being vigilant in monitoring on busy streets.

## Fire Company's Report

The September 2019 Southmont Volunteer Fire Company report was received and is on file. Mr. Butler expressed concern for road safety of the fire trucks on certain streets where people are parking close to the intersections and by fire hydrants. Mr. Butler was asked to make a list of streets where the problem exists.

#### **Engineer's Report**

Mr. Banks stated Phase II of the Sanitary Sewer Replacement Project is closing out in November and he recently met with Snyder Environmental and Mr. Lingenfelter to perform the 11 month punch list of items that still need addressed. Mr. Banks reported the lateral at 266 Southmont Blvd. was missed due to it being close to the Johnstown City line and noted a grinder pump would be needed at the property.

A motion was made by Mr. Ewald to install the lateral line and grinder pump at 266 Southmont Blvd. to the engineer's specifications. Motion seconded by Mrs. Speicher. Mr. Pile absent. All in favor, motion carried (6-0).

Mr. Banks requested permission to remove the six flow meters throughout the borough for the season and reinstall them in the spring due to the cost and no accurate testing can be done during the winter.

A motion was made by Mr. Ewald to approve removing the flow meters and reinstall in spring 2020. Motion seconded by Mr. Danyluk. Mr. Pile absent. All in favor, motion carried (6-0).
