ORDINANCE NO. 465

AN ORDINANCE SETTING THE GARBAGE FEE FOR THE CALENDAR YEAR OF 2007 FOR THE COLLECTION AND DISPOSAL FOR GARBAGE AND RUBBISH FROM RESIDENTS AND PROPERTY OWNERS OF THE BOROUGH AT A FEE OF \$120.00 FOR THE CALENDAR YEARS 2007, 2008 AND 2009.

**BE IT RESOLVED** by the Council of the Borough of Southmont, Cambria County, Pennsylvania, in pursuance of authority granted to Boroughs by the Act of Assembly, 1966, February 1, P.L. 581 (1065) Section 1202 as follows:

**BE IT RESOLVED** by the Council of the Borough of Southmont, Cambria County, Pennsylvania, pursuant to the authority granted to the Borough sets the garbage and rubbish fee known as the Municipal Service Fee as follows:

SECTION 1: The annual fee of the Borough of Southmont, called the “Municipal Service Fee”, as provided by Section 3 of Ordinance No. 265 of the Borough, passed January 11, 1979, as amended by Ordinance for the calendar years 2007, 2008 and 2009 shall be the sum of one hundred twenty dollars (\$120) per year per household.

SECTION 2: Payment of the annual fee herein established shall be made to the Borough Secretary upon billing January 2007, January 2008 and January 2009 of one-half of the fee equaling \$60.00 and shall be payable at face amount for a three week period. If this fee is not paid by the due date of the said month, next following the bill thereof, a penalty of 10% shall be added. If not paid by May 1, 2007, May 1, 2008 and May 1, 2009, it shall be delinquent and turned over to District Magistrate for collection plus magistrate’s fees and costs.

The Borough Secretary shall bill in July 2007, July 2008 and July 2009 of one-half of the fee equaling \$60.00 and shall be payable at face amount for a three week period. If this fee is not paid by the due date of the said month, next following the bill thereof, a penalty of 10% shall be added. If not paid by November 1, 2007, November 1, 2008 and November 1, 2009, it shall be delinquent and turned over to District Magistrate for collection plus magistrate’s fees and costs.

SECTION 3: All other provisions of said Ordinance Nos. 265, 275, 294, 300, 338, 347, 351, 353, 356, 364, 369, 383, 398, 429, 437 and 443 and the provisions relating to the time of payment of said Municipal Service Fee and penalties thereon established by Ordinance No. 285 passed December 1, 1976, not inconsistent herewith, are repropose and confirmed.
