Mr. Rodgers made a motion to have the regular Council meetings be held on the third Monday of every month at 7:00 p.m. except the meeting in December which should be held on December 11, 2006. The Committee meetings should be held on Tuesday, as needed, at 7:00 p.m. Seconded by Mr. Krupa. All in favor, motion carried. Mr. Kory absent. Ms. Spak will advertise the meeting schedule. Mr. Rodgers made a motion for Kris Cramer, CPA Kline Kimlin, to perform the 2005 Borough Audit; audit to start week of January 23rd. Seconded by Mr. Strittmatter. All in favor, motion carried. Mr. Kory absent.

Mr. Ewald mentioned his concerns regarding Ordinance #460 animal control laws and prohibiting the harboring of an animal nuisance, which allows no barking after 9:00 p.m. President Pile stated this will be discussed at the next meeting. The Committee meeting that was scheduled for Tuesday, January $10^{\rm th}$ will be changed to Monday, January $16^{\rm th}$.

Mr. Rodgers made a motion to adjourn. Seconded by Mr. Strittmatter. Meeting adjourned at 7:16 p.m.
