ORDINANCE NO. 269

AN ORDINANCE OF THE BOROUGH OF SOUTHMONT, CAMBRIA COUNTY, PENNSYLVANIA, SIGNIFYING THE DESIRE AND INTENTION OF SAID WESTMONT HILLTOP RECREATION AUTHORITY TO ORGANIZE A JOINT AUTHORITY UNDER THE MUNICIPALITY AUTHORITIES ACT OF MAY 2, 1945, P. L. 382, AS AMENDED, TO BE KNOWN AS WESTMONT HILLTOP RECREATION AUTHORITY; APPOINTING THE MEMBERS OF THE BOARD OF THE AUTHORITY AND SETTING FORTH THEIR RESPECTIVE TERMS OF OFFICE; SETTING FORTH THE PROPOSED ARTICLES OF INCORPORATION AND AUTHORIZING THE PROPER OFFICERS OF THE BOROUGH OF SOUTHMONT TO EXECUTE SAID ARTICLES OF INCORPORATION FOR AND ON BEHALF OF THE SAID BOROUGH.

Be it enacted and Ordained by the Borough Council of the Borough of Southmont, Cambria County, Pennsylvania, and it is hereby enacted and ordained by authority of the same:

SECTION I. That it is the desire of the Borough Council of the Borough of Southmont, Cambria County, Pennsylvania, and the Borough Council hereby signifies its intention, together with the Borough of Westmont and the Township of Upper Yoder, to organize a Joint Authority under the Municipality Authorities Act of May 2, 1945, P. L. 382, as amended.

SECTION II. The name of the proposed Authority shall be Westmont Hilltop Recreation Authority.

SECTION III. The following persons are hereby appointed members of the Board of Westmont Hilltop Recreation Authority for the terms of office indicated:

SECTION IV. Pursuant to said desire and intention of the Borough Council and in conformance with the terms and provisions of said Municipality Authorities Act of 1945 and its amendments, the proposed Articles of Incorporation are hereby set forth in full, as follows:

SECTION V. The proposed Articles of Incorporation of the said Joint Authority shall be executed by and on behalf of the Borough of Southmont by the President of Council and the Mayor, and the seal of said Borough shall be thereto affixed and attested by the Borough Secretary, and filed with the Secretary of the Commonwealth. Attorney Gustave S. Margolis is hereby authorized and directed to cause to be published the notice of intention to file the Articles of Incorporation with the Secretary of the Commonwealth as required by the aforementioned Act. No additional publication of this Ordinance is required.

SECTION VI. All Ordinances or parts of Ordinances not in accord with this Ordinance are hereby repealed.
