

ORDINANCE NO. 115

AN ORDINANCE AMENDING ORDINANCE NO. 113 AUTHORIZING THE OPENING OF A STREET IN THE BOROUGH OF SOUTHMONT, FROM THE EXTENSION OF GRANT STREET AT THE LINE OF THE CITY OF JOHNSTOWN TO THE LINE OF WESTMONT BOROUGH AT A POINT ON MILLCREEK ROAD.

Section 1. Be it enacted and ordained by the Council of the Borough of Southmont, and it is hereby enacted and ordained, that a street or road be opened within the Borough of Southmont from a point on the city line of the City of Johnstown, being the extension of Grant Street; thence South  $35^{\circ} 38'$  East, a distance of one hundred eighty-six and fifty-nine one-hundredths (186.59) feet; thence by an arc to the right with a radius of 287.94 feet, a distance of three hundred sixteen and fifteen hundredths (316.15) feet; thence South  $26^{\circ} 56' 30''$  West six hundred seventy and forty two hundredths (670.42) feet; thence by an arc to the left with a radius of 1910.08 feet, a distance of three hundred fourteen and forty-four hundredths (314.44) feet; thence South  $17^{\circ} 30' 30''$  West nine hundred seventeen and seven hundredths (917.07) feet; thence by an arc to the right with a radius of 716.78 feet, a distance of six hundred eighty-six and twenty-five hundredths (686.25) feet; thence South  $72^{\circ} 24' 30''$  West, three hundred ninety-seven and sixty-six hundredths (397.66) feet; thence by an arc to the right with a radius of 716.78 feet, a distance of eight hundred two and seventy one hundredths (802.71) feet; thence North  $42^{\circ} 22' 30''$  West, three thousand eight hundred twenty eight and thirty three hundredths (3828.33) feet; thence by an arc to the left with a radius of 955.27 feet, a distance of seven hundred fifty-eight and sixty-one hundredths (758.61) feet to the Borough line of the Borough of Westmont at a point along Millcreek Road.

Section 2. Said Road shall have a uniform width of eighty (80) feet.

Section 3. The proper officers of the Borough of Southmont are hereby authorized and directed to take such legal steps as may be necessary for the opening of said street, and for the assessment of damages and benefits by reason thereof before said street is actually opened.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
