

ORDINANCE NO. 272

AN ORDINANCE OF SOUTHMONT BOROUGH, CAMBRIA COUNTY AND THE COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 1973 AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR THE SPECIFIC PURPOSES OF THE MUNICIPAL GOVERNMENT, HEREINAFTER SET FORTH, DURING THE CURRENT YEAR AND FIXING SALARIES AND WAGE RATES FOR THE YEAR 1973.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of SOUTHMONT BOROUGH, COUNTY OF CAMBRIA, PENNSYLVANIA

SECTION 1. That a tax be and the same is hereby levied on all property within said municipality subject to taxation for the fiscal year 1973, as follows:

Tax rate for general purposes, the sum of eleven (11) mills on each dollar of assessed valuation:

Making a total tax rate for all Borough purposes of eleven (11) mills.

SECTION 2. That for the expenses for the fiscal year 1973 the following amounts are hereby appropriated from the revenues available for the current year for the specific purposes set forth below, which amounts are more fully itemized in the Budget Form.
