MINUTES FOR MAY 19, 2025

The pledge of allegiance was conducted, and the scheduled May 19, 2025, council meeting was called to order by Vice President Speicher at 4:00 p.m.

Present: Council Members Sheree Speicher, Robert Morgan, Richard Burkert, Eugene Kupchella, Herb Ewald, Matthew McVicker, Mayor Anthony Keiper, Borough Manager Amanda Layton; Street Commissioner Sam McAdams; Sgt. William "B.J." Newman, Engineer Todd Banks, Asst. Sec Debra Riek

Public Comments: Mr. Walker questioned who enforces the ordinances for the borough noting there had been nothing done with sidewalks needing repaired or not being cleared of snow during winter. Mr. Walker stated that some people are not getting building permits and he has noticed a few sheds have been erected without permits and the borough needs to enforce the ordinances for zoning. Mr. Walker stated that Westmont Borough is having their street work crew reporting on blighted properties, and maybe Southmont Borough could do the same.

Mr. Klanchar told council that he will be running as a write-in this election. Mr. Klanchar stated that zoning and building permits seem to be selective and questioned what plans the borough has for the Southmont Diamond Blvd. playground and he would be in favor of improvements to the playground area. Mrs. Speicher stated the playgound is on the agenda and would be discussed later in the meeting.

Greater Johnstown Water Authority: Mr. Kupchella reported grant funding for work at North Fork Dam has been received. Mr. Kupchella stated the authority is working with Peoples Natural Gas to

Shade Tree: Mr. Burkert reported that the borough's grant application through the Community Foundation for the Alleghenies was approved for \$1,200.00, which will be used as match funding toward a larger grant through the Department of Conservation and Natural Resources requesting funding to complete a shade tree inventory.
